\*I/Each of us understand(s) that \*I/we must make a Declaration of Secrecy in advance and produce such Declaration of Secrecy and \*my/our Hong Kong Identity Card when reporting to the relevant Returning Officer/Assistant Returning Officer/ Presiding Officer for which the counting agent is appointed on attending the counting station/ballot paper sorting station on the polling day.

\*I/Each of us understand(s) that \*I/we **must not**—

- (a) 向他人傳達在點票時取得的資料，包括任何一張選票所選之候選人；  
communicate to any person any information obtained at the counting of the votes including the candidate(s) for whom a vote has been given on any particular ballot paper;
- (b) 觸摸、處理、分開或排列選票；  
touch, handle, separate or arrange ballot papers;
- (c) 干擾或企圖干擾任何投票箱、選票結算表、選票結算核實書或覆核書、或其他有關的選舉物料；或  
interfere with or attempt to interfere with any ballot boxes, ballot paper accounts, verifications or re-verifications of ballot paper accounts or other relevant election materials; or
- (d) 在點票過程拍影片、拍照、錄音或錄影。  
film, take photograph or make any audio or video recording during the counting process.

8. \*我／我們亦明白，倘若\*我／我們在點票站／選票分流站內或其鄰近範圍內行為不檢或行為不當，或不遵從有關的選舉主任、助理選舉主任或票站主任的任何合法命令，即屬違法，可被判罰款及監禁，並可能會被有關的選舉主任、助理選舉主任或票站主任命令立即離開該地方。倘若\*我／我們沒有離開，可能會被警務人員或獲有關的選舉主任、助理選舉主任或票站主任（視何者適用而定）以書面授權的人員逐離該地方。\*我／我們被逐離後，除非獲得有關的選舉主任、助理選舉主任或票站主任的許可，否則\*我／我們不得再次進入點票站／選票分流站。

\*I/Each of us also understand(s) that if \*I/we misconduct \*myself/ourselves or behave in disorderly manner at or in the vicinity of the counting station/ballot paper sorting station, or fail to obey any lawful order of the relevant Returning Officer, the Assistant Returning Officer or the Presiding Officer, \*I/we shall commit an offence punishable with a fine and imprisonment and may be ordered by the relevant Returning Officer, the Assistant Returning Officer or the Presiding Officer to leave the area immediately. \*My/Our failure to leave the area may result in \*my/our being removed by a police officer or person authorized in writing by the relevant Returning Officer, the Assistant Returning Officer or the Presiding Officer (as may be appropriate). If \*I am/We are so removed, \*I/we may not re-enter the counting station/ballot paper sorting station except with the permission of the relevant Returning Officer, the Assistant Returning Officer or the Presiding Officer.

# 填寫監察點票代理人委任通知書說明

## Notes on Completion of Notice of Appointment of Counting Agent

1. 除非候選人以指明表格明文另作示明，有關代理人須當作是為在預定日期進行的投票中和（如適用的話）於遭押後的該次投票中所投的票的點算而委任。

The relevant agent is to be regarded as being appointed for the counting of the votes cast in the poll to be conducted on the scheduled date and (where applicable) the postponed or adjourned poll, unless the candidate expressly indicates otherwise in the specified form.

2. 每名候選人或其選舉代理人可就每個點票站及選票分流站委任一（1）名監察點票代理人。凡年滿 18 歲的香港身分證持有人均可被委任為監察點票代理人。候選人或其選舉代理人不應委任任何選舉主任、助理選舉主任、或任何已受選舉主任或民政事務總署署長委任協助進行投票或點票的人士為其監察點票代理人。

Each candidate or his/her election agent may appoint one (1) counting agent for each counting station and ballot paper sorting station. Any person who is a holder of a Hong Kong Identity Card and has attained the age of 18 years may be appointed as a counting agent. A candidate or his/her election agent should not appoint any Returning Officer, Assistant Returning Officer, or any person already appointed by the Returning Officer or the Director of Home Affairs to assist at the poll or at the count as his/her counting agent.

3. 此通知書的第一部分應由候選人或其選舉代理人填寫及簽署。第二部分應由監察點票代理人填寫及簽署。  
PART I of this notice should be completed and signed by the candidate or his/her election agent. PART II should be completed and signed by the counting agent.

4. 填妥的監察點票代理人的委任通知書須於投票日前三（3）天之前藉專人送遞、郵遞、電子郵件或圖文傳真方式交付予有關鄉郊地區的選舉主任，或於投票日由候選人或其選舉代理人親自交付予有關監察點票代理人所負責的點票站／選票分流站的票站主任／選舉主任／助理選舉主任（視何者適用而定）。逾期遞交的通知將不予接納。監察點票代理人的委任，在有關的票站主任／選舉主任／助理選舉主任（視何者適用而定）接獲委任通知書後始生效。

The duly completed notice of appointment of counting agent must either be delivered to the relevant Returning Officer for the relevant rural area by hand, by post, by electronic mail or by facsimile transmission before the three (3) days preceding polling day, or be delivered by the candidate or his/her election agent in person to the Presiding Officer/Returning Officer/Assistant Returning Officer of the counting station/ballot paper sorting station for which the counting agent is appointed on the polling day (as may be appropriate). Late submissions will not be accepted. The appointment of counting agent will not be effective until the notice of appointment is received by the relevant Returning Officer/Presiding Officer/Assistant Returning Officer, as may be appropriate.

(a) **資料用途**

就此通知書提供的個人資料及其他有關的資料，會供選舉管理委員會、民政事務總署、有關鄉郊地區的選舉主任、有關點票站的票站主任／選票分流站的助理選舉主任及有關的政府部門用於與選舉有關的用途。

**Purpose of Collection**

The personal data and other related information supplied in connection with this notice will be used by the Electoral Affairs Commission, the Home Affairs Department, the Returning Officer for the relevant rural area, the Presiding Officer for the relevant counting station/ Assistant Returning Officer for the relevant ballot paper sorting station and related government departments for election-related purposes.

(b) **資料轉介**

就此通知書提供的個人資料及其他有關的資料可能會提供予其他獲授權的部門或人士，包括但不限於法院，用於與選舉有關的用途。

**Transfer of Information**

The personal data and other related information supplied in connection with this notice may be provided to other authorized departments or persons, including but not limited to the law courts for election-related purposes.

(c) **索閱個人資料**

任何人有權根據《個人資料（私隱）條例》（第 486 章）的條文要求索閱及改正他／她所提供的個人資料。

**Access to Personal Data**

Any person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) **個人資料保障原則**

候選人／選舉代理人應留意，在收集第三者的個人資料以填寫此通知書時，須遵守《個人資料（私隱）條例》（第 486 章）附表 1 的保障資料原則，特別是第 4 原則，即採取所有切實可行的步驟，以確保個人資料受到保障而不受未獲准許的或意外的查閱、處理、刪除、喪失或使用。

**Personal Data Protection Principles**

Candidates/Election agents are reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap.486) in collecting personal data of a third person in completing this notice, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that personal data are protected against unauthorized or accidental access, processing, erasure, loss or use.
